

Transportation/Infrastructure Client Successes

➤ **Rail Depot**

Secured \$50 million to save an early 20th-century rail depot and implemented a winning strategy resulting in formal federal designation as a multimodal transportation center.

➤ **Interstate Highway Bridge Project**

Secured targeted appropriations funding and federal designation in the TEA-21 transportation authorization bill for a coalition of local governments and community based organizations. Improved the project's position on the state's Department of Transportation priority build list, moving the bridge ahead 10 years.

➤ **Trunk Highway Project**

Secured \$9.4 million in funding from FY2004-FY2009 to expand and improve a main thoroughfare running through the heart of a small community's downtown, aiding in significant congestion relief and subsequent economic development.

➤ **Aviation Noise Mitigation**

Assisted a client community in securing \$155 million in airport funds to mitigate outside the 65DNL contour – an unprecedented victory for the client and all of America's cities.

➤ **Port Authority**

Secured "Brownfield" designation for a targeted neighborhood, opening the doors for millions in federal funds for mitigations and infrastructure development.

➤ **Regional Rail Project**

Secured \$1 million for rehabilitation work for a regional short-line railroad, assisting in rail improvements of significant benefit to shippers along the rail line as well as several integrated multi-modal transportation and economic development projects in the region.

➤ **Community Works Project**

Obtained over \$7,000,000 for a project integrating transit and transportation alternatives into the community, resulting in job creation and better access to employment opportunities.

➤ **Bike/Pedestrian Corridors**

Worked to secure a highly innovative \$25 million "non-motorized transportation pilot project" for the client city.

➤ **National Transportation Research**

Obtained a \$20 million investment for joint FAA/NASA research to spur development of a next generation of quieter aircraft technology.
